## **NOTICE TO SHAREHOLDERS**

Shareholders of the SICAV are hereby informed of the following changes to the prospectus for the SICAV (the "**Prospectus**").

Capitalised terms used in this notice shall have the meaning given to them in the Prospectus unless otherwise provided therein.

As part of its strategic plan, the Natixis Investment Managers group (the "**Group**") wishes to improve its model and simplify its organization. As such, it was decided to transfer the activities of Seeyond to Ostrum Asset Management ("**Ostrum**"), another entity of the Group. Such transfer of the activities of Seeyond to Ostrum will be carried out by way of a merger which will take place on 1<sup>st</sup> January 2023.

This transfer of activities will enable Ostrum to offer new sources of diversification to its clients by expanding its current offer with additional quantitative management expertise.

Seeyond's current teams will transfer with the business and continue to focus on the performance and risk management of the Sub-funds ("**Sub-Funds**") in which you are invested.

As a result of the above, the Prospectus will be updated accordingly as further detailed below.

### **CHANGES WITH EFFECT FROM 1<sup>st</sup> JANUARY, 2023**

The relevant section ("Delegated Investment Manager of the Sub-Fund") in the supplements (of the Prospectus) of the following Sub-Funds that are currently managed by delegation by Seeyond will be amended to replace the name of Seeyond by Ostrum as the new Delegated Investment Manager of the Sub-Funds:

- Seeyond Multi Asset Conservative Growth Fund,
- Seeyond Multi Asset Diversified Growth Fund,
- Seeyond Europe Sustainable MinVol\*,
- Seeyond Global Sustainable MinVol\*,
- Seeyond Volatility Strategy,
- Seeyond Volatility Alternative Income\*.

*\*This sub-fund is not registered in Austria.*
